Minnesota Brownfields Announces ReScape Award Project Finalists that Revitalize Formerly Contaminated Land

SAINT PAUL, Minn. – (October 7, 2015) – Minnesota Brownfields is celebrating 12 finalist projects demonstrating innovation, collaboration, and exemplary results in re vitalizing formerly contaminated land throughout Minnesota. Winners will be announced at an awards ceremony at Union Depot in Saint Paul on November 12, 2015, from 5:00 – 7:30 p.m.

This 4th annual event will include a Redevelopment Showcase, a seated dinner, and networking. Winning projects feature transformation of abandoned or underutilized sites using innovative solutions to significant environmental issues.

“Brownfield redevelopment is an effective way to generate economic growth,” said Commissioner Katie Clark Sieben of the Minnesota Department of Employment and Economic Development (DEED). “The Minnesota Brownfields ReScape Awards are a fantastic opportunity to highlight projects that have cleaned up contamination, created jobs and increased the local tax base.”

“The ReScape Awards recognize the unique redevelopment challenges posed by brownfield sites, the partnerships required to revitalize them, and the various ways that revitalization benefits communities. These projects can serve as models for future redevelopment”, stated Executive Director Martha Faust.

The call for project nominations closed on September 17. Seventeen project nominations were received representing seven Minnesota cities. Minnesota Brownfields is continuing to work with a local artist to create award statues that captures the themes of land reuse and sustainability. Alli Luhmann of FOCI Minnesota Center of Glass Arts is creating an original design using recycled glass and steel.
